2019 Trinity River Photo Contest Rules

Sponsor

Sponsor is Trinity Park Conservancy, 1444 Oak Lawn Avenue, Suite 200, Dallas, TX 75207.

Term

The 2019 Trinity River Photo Contest (“Contest”) begins April 15, 2019 at 12:00:00pm CDT and ends October 14, 2019, 11:59:59pm CDT. ALL ENTRIES MUST BE RECEIVED BY OCTOBER 14, 2019 AT 11:59:59PM CDT.

Eligibility

The Contest is open to all photographers of any age.

Employees of the Trinity Park Conservancy, and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they live) or persons living in the same households of such employees, whether or not related are not eligible.

How to Enter

Each entry consists of an entry form and a single photograph. There is no fee to enter photography into this Contest. To enter, visit <https://trinityparkconservancy.org/enjoy-it-now/events/photo-contest/>; complete an entry form with the required information, including your name, address, phone number, email address, division and category of the submission, photo caption, and the location the photo was taken; and submit along with your photograph.

The categories for entries are: (1) Nature, (2) People, (3) Places. Each entrant can submit a maximum of two (2) photographs per category, for a total of six (6) photographs per person. Photographs must meet the following requirements:

1. Photographs must be taken within the Trinity River Corridor, defined as the area between I-35 North at Webb Chapel to Hwy 175-S at I-20. Photos should be taken no more than 100 feet outside of the levees.
2. Photographs must be in digital format. Only online entries will be eligible. No print or film submissions will be accepted for entry into this Contest. The photograph need not be taken with a digital camera; scans of negatives, transparencies, or photographic prints are acceptable. All digital files must be 10 megabytes or smaller, must be in JPEG or .jpg format, and must be a minimum of 1,600 pixels wide (if a horizontal image) or 1,600 pixels tall (if a vertical image).
3. Photographs must have been taken within one (1) year prior to the date of entry (after March 2, 2018) and many not previously have won a award in the Trinity River Photo Contest.



4. All photographs should accurately reflect the subject matter and the scene as it appeared. Photos that have been digitally altered beyond standard optimization will be disqualified.
5. Photographs that include sculptures, statues, and other works of art will be accepted as long as they do not constitute copyright infringement or fraud; provided entrants must be prepared to provide a release form. When photographing the work of others, it must be as an object in its environment and not a full-frame close-up of another person's art.
6. The photograph, in its entirety, must be a single work of original material taken by the Contest entrant. By entering the Contest, entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
7. The photograph must not, in the sole and unfettered discretion of the Sponsor, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
8. The caption must be complete and accurate, sufficient to convey the circumstances in which the photograph was taken. Disguising or misrepresenting the origin of your content is cause for disqualification.
9. Watermarks are unacceptable. Unless Sponsor receives a non-watermarked version of the entry within ten (10) days following its request, the entry will be disqualified.

The entries in each category will be judged separately, in accordance with the criteria described below. All entries must be received by October 14, 2019 at 11:59:59pm CDT. Proof of submission is not proof of receipt. We reserve the right to examine the original photograph/source materials in order to confirm compliance with these rules.

Judging

Judging will consist of 2 rounds of evaluation. In the first round, each judge (in a panel of photographic experts) will independently review and evaluate entries for one Contest category. Photographs will be judged on originality, technical excellence, composition, overall impact, and artistic merit.

Round two, compile the resulting evaluations and review the submissions together, selecting a First and Second prize, and assign honorable mentions for each category and in each division of the Contest. Judges will then select a grand prize winner.

Winners will be chosen in October and will be notified by email. Checks are distributed by mail. A valid email address and mailing address must be provided to receive prize money, if selected. Decision of the Judges are final and binding.

Releases

If the photograph contains any material or elements that are not owned by the entrant and/or which are subject to the rights of third parties, and/or if any persons appear in the photograph, the entrant is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph. If any person appearing in any photograph is a minor (under the age of 18), the signature of a parent or legal guardian is required on each release.

License

Your entry in the 2019 Trinity River Photo Contest constitutes your agreement to allow your photographs - and your name, city, state of residence (school and grade for youth participants) - to be published as award winners, or used on Web sites or in printed and promotional materials owned and/or produced by Trinity Park Conservancy, and its sponsors, affiliates or partners. Entrants retain ownership and/or the use of their photographs and grant an irrevocable and perpetual non-exclusive license to Trinity Park Conservancy and contest sponsors, affiliates, or partners, to reproduce, distribute, and display works of the entries (along with a name credit) in any media now or hereafter known, for no additional compensation. Display or publication of any entry does not indicate that the entrant will be selected as a winner.

Prizes

Prizes will be awarded to winning images in each category for Professional, Amateur, and Youth divisions. The grand prize, 1st and 2nd place winners, and Honorable Mentions will be determined at the Judge's discretion. The Trinity Park Conservancy and sponsors have the right to verify winner eligibility.

Winners who receive cumulative awards amounting to greater than 600, will be required to complete a W-9 form to receive the monetary award.
